The goods and services shown within are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangement you select will include a charge for our services. If legal or other requirements mean you **must** buy an item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral service and merchandise you selected.

This list may not include prices for certain items you select such as cemetery charges or crematory services and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We charge you for our services in buying certain items.

Alternative Services

The following charges for direct burial and direct cremation do not include additional items of service, merchandise, use of facilities and livery that the customer may wish to select.

Direct Cremation

Prices range from \$4,000.00 to \$5,250.00

All Direct Cremation options includes the local transfer of remains to the funeral firm, the services of the funeral director and staff, securing of necessary authorizations, basic and local transportation to the crematory and the return of the cremated remains to the funeral home. (The charges for Direct Cremation do not include the crematory charges or additional items of service, merchandise, facilities, and livery that the customer may wish.)

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composite materials (with or without and outside covering) or may be pouches of canvas or other materials.

We offer an alternative container made of cardboard. It is unlined and unfinished.

Our charges for direct cremation (without ceremony or other services of the funeral director or staff) include; Removal of remains, transportation to crematory and minimum services of staff.

Direct Cremation with the container supplied by the purchaser. (All such containers must meet any applicable state or crematory requirements)	\$4,000.00
Direct Cremation with a corrugated cardboard container, no exterior finish.	\$4,450.00

Direct Burials

We offer two basic packages for direct burials.

Direct burial prices do NOT include cemetery or other cash advance items, or merchandise selected. Prices range from \$5,250.00 to \$5,410.00.

The first package included local transfer of remains to the funeral home, services of the funeral director and staff, securing of necessary authorizations, basic local transportation to the cemetery and an unlined plain pine casket. \$5,410.00

The second package includes the services as described above but with the burial container supplied by the purchaser. (Burial container must meet any state or cemetery requirements.) \$5,250.00

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement which does not require you to pay for it (embalming) such as direct cremation or direct/immediate burial. If you select certain funeral arrangements such as a viewing or an open casket funeral, embalming may be required by the funeral firm.

Preparation of the remains, unless selected, is not required for direct cremation or direct burial.

Forwarding of Remains to Another Funeral Home \$3,795.00

This charge includes the local transfer of the remains to the funeral home, staff services, securing of necessary authorizations, and local transportation to the point of shipment. The charge does not include shipping charges or additional items of services, merchandise, facility use and livery that the customer may select.

Transportation beyond local point of shipment will be billed either as livery or common carrier charges depending upon the forwarding location. Local point of shipment is up to or within 10 miles.

Receiving Remains from Another Funeral Home \$3,795.00

*This charge includes the basic local transportation of the remains to the funeral home firm and/or place of local disposition, and arrangements, which include services of the funeral director and staff plus required authorizations. The charge does **not include** additional items of service, merchandise, facility use, and livery that the customer may wish to select. Transportation beyond local point of shipment will be billed as livery charges. Local point of disposition is up to or within 10 miles.*
